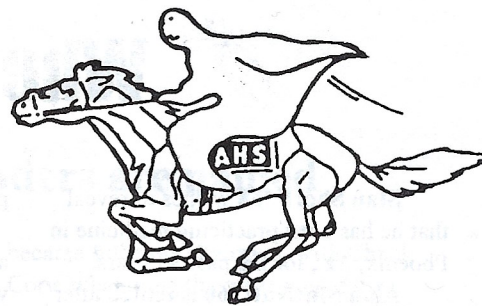

She was treated to dinner on her birthday by several Abington alumni as pictured above and presented with an honorary Century Club membership in the Abington High School Alumni Association.

Sally was 70 when she began helping out at Abington Memorial Hospital and has worked there for 30 years. At the time of her birthday, she was working in the Same Day Procedures unit every Friday, assisting patients and preparing their rooms. She also works two days each week as a volunteer with the Red Cross. When asked why she contin-

Before becoming a hospital volunteer, Sally worked for nearly 30 years as a substitute kindergarten teacher in the Abington School District. Before that,

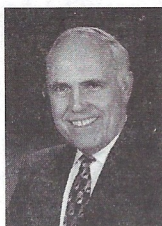

Football team thrives in new Schwarzman stadium

Coach Tim Sorber led Abington's football team to a 7-5 record. Highlights of the season included a one-point loss to district playoff contender Pennsbury, a victory over a strong Plymouth-Whitemarsh team in the season home opener, and a victory over Council Rock North. In one of the most exciting games in a long time, Abington rallied for 8 points with less than two minutes left in the game to tie Cheltenham, scored 7 points in

Heads of Fifty Plus Club retire; new leaders are named

Credit for the Fifty Plus Club beginnings goes to the reunion committee of the Class of 1924, who founded what was then called The Twenties Club. The committee consisted of Thora Simons Bonnell, Sarah Stevens Willett, Thomas Ober, Mabel Mooney, and Louis Oswald. For their 50th reunion in 1974, they invited all classes from the 1920s to participate in a luncheon. As attendance at the luncheon grew, the name was changed to the Fifty Plus Club, and in 1982, when Lin Shaffer '32 took charge, the meeting place was established at LuLu Country Club. Later, the job of handling funds and reservations was turned over to Earl Jenkins '36, who soon realized that LuLu was becoming

Class of '45 gives \$7,500 donation to scholarship fund

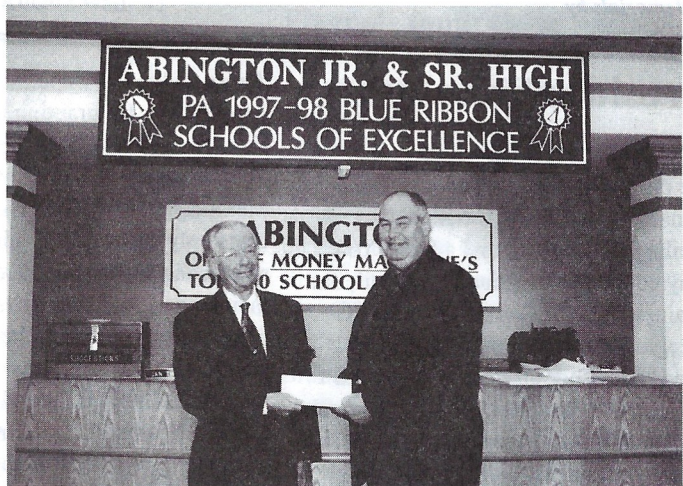
At its 60th and final reunion last fall, half the living members of the Class of January '45—the last mid-year graduation from Abington High School—took a trip down memory lane with extensive displays of photos and memorabilia from their high school years. The class, which numbered 86 at graduation, has met regularly at five-year intervals with good attendance.

At earlier reunions, class members had often remarked on their gratitude for the rich experiences they had at Abington, and for the preparation that enabled them to go on to successful careers. To show their appreciation, and in recognition of the needs of current Abington students for post-secondary education, they established a January '45 class gift fund. Sixty-seven percent of the living class members contributed. This March, the class presented a \$7,500 check to the Alumni Association towards its scholarship endowment. Hall of Fame

On September 9, 2005, Abington Senior High School inducted the following alumni into the Hall of Fame. The inductees were selected by a committee consisting of alumni and high school faculty, with the Alumni Association choosing the posthumous awardee.

Michele "Myke" Williams '66 (Education). An outstanding social studies teacher and member of the Abington School District community for 34 years, teaching at the junior and senior high schools. Her strong personal commitment to her students was exemplified by the endless hours she spent encouraging and enabling students of low self-esteem to achieve their full potential.

Stephen A. Schwarzman '65 (Business). Founder, president, and chief executive officer of the Blackstone Group LP, one of the largest asset management groups in the world. Deeply involved in the arts, politics, and philanthropy, he serves as chairman of the board for the Kennedy Center for the Performing Arts, is a member of the Council on Foreign Relations, and on the boards of the New York Public Library and the New York City Ballet.

William J. Landherr, Jr., '55 (Service). Founder of Corro Therm Inc. of Feasterville, Pa., manufacturer and applicator of technical coatings since 1971. A retired captain in the Naval Reserve, he has served as leader of numerous humanitarian and service organizations. A member of the Alumni Association's board for 20 years, he has served as the Association's president since 1998.

Capt. James C. Gibson '52 (Government). He earned a Navy Reserve Officer Training Corps scholarship to Princeton University and later earned a master's degree in engineering. Now retired, he served in the Naval Nuclear Engineering program on the staff of Adm. Hyman Rickover

and later distinguished himself as a designer of naval shipboard equipment.

Dawn R. Chamberlin '82 (Athletics). Distinguished field hockey coach at Salisbury University in Maryland since 1987 and winner of NCAA Division III championships the past three years with a combined record of 63-2. She ranks among the most successful coaches in school history with a record of 284-79-8 through 19 seasons. Named Capital Athletic Conference Coach of the Year for each of the past 10 years.

Kenneth Kenyon '50 (Arts). Chief research librarian for 20th Century Fox Films, where he worked for 35 years, maintaining and organizing more than 150,000 publications in the library. In retirement, he worked as executive historian of the Ronald Reagan Presidential Library.

Emory W. Zimmers, Jr., '61 (Science). Received four engineering degrees from Lehigh University, where he is professor of industrial and systems engineering. He has received five teaching awards and has more than 20 years research administration experience, including as deputy director of the Iacocca Institute. He is director of the National Science Foundation's Center for Engineering Logistics and Distribution.

Amy Jill Sacks '72 (Posthumous). A cum laude graduate of Harvard University and the world's first female television sports producer, she also worked as a senior producer for ABC's "Prime Time Live," played a major role in the network's coverage of the 1984 and 1988 Olympics, and was an associate coordinating producer for ABC's Wide World of Sports. Before her death at age 39, she won 13 Emmy awards, two Pinnacle awards, and a Christopher award for coverage of the 1983 Special Olympics.

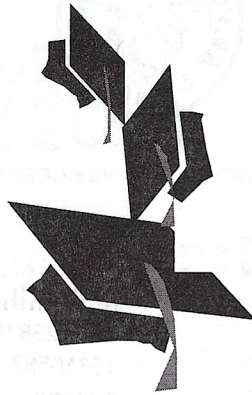
