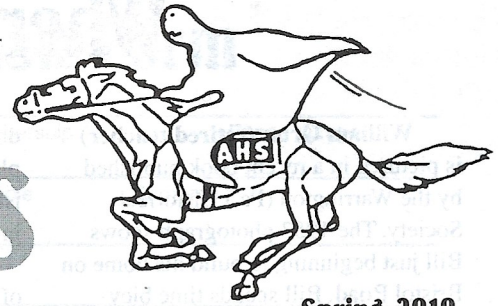

## Sichel garners awards, is Pa. Superintendent of the Year

Dr. Amy Sichel was named 2010 Pennsylvania Superintendent of the Year by the Pennsylvania Association of School Administrators. Abington School District students, staff, parents, and graduates can be proud that Dr. Sichel was selected as the top superintendent among the 500 state school districts in Pennsylvania.

A second honor was afforded to Dr. Sichel when she was notified that she was a national winner in the 2010 Tech-Savvy Superintendent Competition for her exemplary vision in the use of technology in the school district. Ten winners were named in the United States from 600 applications.

Dr. Sichel received a bachelor of arts in psychology from Lafayette College, a master of science in psychological services from the University of Pennsylvania, and her doctorate of philosophy in school psychology, also from the University of Pennsylvania. She returned to the University of Pennsylvania for her principal certificates and letter of eligibility for superintendency.

Unlike most of the previous Abington superintendents, Dr. Sichel rose through the ranks. She began as an elementary counselor in 1976 and then was a school psychologist. She moved to Abington Junior High School in 1983 as the chairperson of guidance and in 1990 became the director of pupil services for the school district. In 1993, Dr. Sichel was appointed as acting assistant superintendent, and the following year became the assistant superintendent. She became superintendent in February 2001.

Since 1981, Dr. Sichel has been very active at the University of Pennsylvania as an adjunct associate professor. She teaches graduate education courses and advises the university on graduate education programs.

Dr. Sichel views diversity as one of Abington's most important strengths. Student achievement scores are in the top 5% statewide with 14% of the student population being from low-income families. Under her leadership, the lowest education tracks were eliminated and broader enrollment in honors and advanced placement courses is encouraged. She advocated the use of high-tech tools. Interactive whiteboards are in



the elementary classrooms and in core curriculum classrooms in the secondary schools.

Abington students donate over 90,000 hours yearly in community service, which Dr. Sichel points to with pride. In a school district of 7,500 students, 90% pursue post-secondary education, and Dr. Sichel states that "our students report back that they leave our schools extremely well prepared for college and careers."

During Dr. Sichel's superintendency, the capital campaign to build a first-class athletic facility became a reality. Schwarzman Stadium

will be enjoyed by students for many years to come. Dr. Sichel is pleased that despite the budget cuts in education, Abington has responded by reducing school property taxes, thus helping the taxpayers—all of this while maintaining educational programs, beneficial class size, and high quality programs.

Dr. Sichel has generously stated that the awards she received represented the dedicated work and commitment of teachers, administrators, supporting staff members, the school board, and the Abington and Rockledge community.

## Visiting the high school?

Abington faculty always enjoys visits with alumni to hear about your successes. ## Remembering Dr. Gerald Hottenstein

Dr. Gerald Hottenstein, a lifetime educator and former popular mathematics teacher at Abington Junior High School in the 1940s, passed away February 11 at age 92. A longtime resident of the North Wales, Pa., area, he was preceded in death by his wife, Sara.

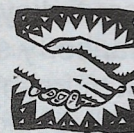
A native of Lebanon, Pa., Dr. Hottenstein graduated from Albright College and received his master's degree from the University of Pennsylvania. He received his doctorate in education from Temple University, and began his illustrious career in Fredricksburg, Pa., before coming to Abington.

He left Abington to become principal in the North Wales School District. He then was named assistant superintendent and subsequently, superintendent of Montgomery County Schools in Pennsylvania. Later he was hired as the superintendent of the Colonial School District and taught in the education department at Villanova University.

Dr. Hottenstein was a strong supporter and involved in the establishment of the Montgomery County Community College.

Three of Dr. Hottenstein's children followed in his footsteps in the educational field. David Hottenstein became a highly respected principal at Hatboro-Horsham High School and later was appointed the district's assistant superintendent. Charles Hottenstein taught health and physical education at Souderton High School, where he was also a very successful boy's basketball and soccer coach. Dr. Hottenstein's daughter, Sally Ann Fredriksen, was a high school social studies teacher in Fairfax County, Va.

Abington School District was lucky to have had Dr. Hottenstein as a teacher, and the educational community will miss his leadership.

After the 2009 *Ghost Stories* went to press, Abington's Brian Deck was named by the Pennsylvania Track and Field Coaches Association "Coach of the Year" for girl's track. His team claimed the state crown last spring. Hurdler Leah Nugent made the All-USA Track team which is chosen by *Track & Field News* magazine.

The football team had another good season and finished with an 8-3 record, losing to Neshaminy in a first-round playoff game. Abington, led all season by quarterback Sam Kind, finished the season by defeating Cheltenham on Thanksgiving Day.

Abington girl's basketball team, led by Villanova recruit Emily Leer, upset top-seeded Cheltenham to win the District One championship. Advancing to the States, Abington defeated Hershey 42-38 in the first round, beat Central Bucks East 50-32 in round two, but lost in double overtime to Red Lion 44-42 in the state quarterfinals. The Ghosts ended a great season under Coach Dan Marsh with a 25-5 record. Emily Leer was named to the first team All-State.

# Hall of Fame

**Arnold J. Malerman, DDS, '61 (Science).** A veteran of the U.S. Air Force, Dr. Malerman was an associate professor at the University of Pennsylvania, and worked to develop curriculum for schools of dental medicine. He was voted "Best Dentist/Orthodontist" five times between 1998 and 2002 by the readers of Montgomery County Newspapers.

**Brig. Gen. Thomas J. Verbeck '69 (Government).** Gen. Verbeck is a distinguished graduate of the Squadron Officer School at Maxwell Air Force Base and Air Command and Staff College, also at Maxwell AFB in Alabama. He served with distinction as chief of staff for two of the largest Air Force commands, Air Combat and Central Command Air Forces. He has been awarded numerous citations, commendations, and decorations during his long service career.

**Marc Vetri '85 (Business).** Mr. Vetri began his culinary training in South Philadelphia and continued with intensive culinary training in Italy and the United States. His New York City restaurant, Beta Blu, was named "Best New Restaurant" in 1996. Mr. Vetri won the James Beard Award for "Best Chef Mid-Atlantic" when he returned to Philadelphia. His successful restaurants in Center City are Vetri and Osteria.

**Susan Francia '00 (Athletics).** Ms. Francia earned All-American honors rowing for the University of Pennsylvania. She has been on five national teams, and has won four world championship titles. Ms. Francia was a member of the gold medal winning women's rowing team at the Beijing Olympics in 2008. She continues to compete and won two gold medals in 2009 in international competition.

**Carol B. Saylor '55 (Arts).** A visual artist who turned to sculpture during 25 years of progressive deafness

and blindness, Ms. Saylor won three "Best in Show" awards at the Armory Show from the Women's Committee of the Pennsylvania Academy of Fine Arts and has taught humanities and fine arts in Bucks County, Pa.

**Michael W. Gillespie '56 (Posthumous).** Mr. Gillespie was a veteran of the U.S. Marine Corps who served as an Abington police officer for 26 years. He was serving his fifth term as Ward 18 commissioner when he passed away in June 2009. He was a member of numerous social service societies and associations.

**Nancy Hislop McPeek '57 (Service).** Mrs. McPeek served in leadership capacities in the Humane Society, Canton (Ohio) YMCA, American Red

Cross, United Way, Child and Adolescent Services Center, Area Agency on Aging, and Kent State University. She was elected to the Stark County Women's Hall of Fame in 1990 and the State of Ohio Senior Citizens Hall of Fame in 2007.

**Nancy D. Kolb '58 (Education).** Ms. Kolb taught at Abington High School, and served as director of the Pennsylvania Historical Museum Commission. From 1998 until 2010, she was president and chief executive officer of the Please Touch Museum in Philadelphia. She spearheaded the museum's recent move and renovation to make it a regional and national point of interest.
